**Cano Funeral Home policy requires a minimum of 20% payment at time of arrangements with balance on contract due and payable in full at least one day prior to final services. Shipouts must be paid in certified funds, i.e., cash, cashier's check, or approved credit card payments.** We accept cash, valid pre-need insurance plans, imprinted personal checks (no out of town checks) and credit cards (**Visa, MasterCard, Discover and American Express**). Credit card payments must be processed at least 3 days prior to service.

# ITEMIZED GENERAL PRICE LISTING

If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral good and services you selected.

## PROFESSIONAL SERVICES OF THE FUNERAL DIRECTOR AND STAFF

**\$ 1095.00**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee includes the following: Personnel available 24 hours a day, 365 days a year to respond to initial call; arrangements conference, coordinating services plans with cemetery, crematory, and/or other parties involved in final disposition of the deceased; clerical assistance in the completion of various documents associated with a funeral; securing and recording the death certificate and disposition permit. This fee also covers overhead, such as facility maintenance, equipment and inventory cost, insurance and administration expenses, and governmental compliance. (This fee is already included in our charges Funeral Service Packages, direct cremations, immediate burials, and forwarding or receiving remains.)

## PREPARATION OF THE BODY

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**ONE DAY SERVICE** ----- \$ 2,505.00  
 This includes the professional services of the funeral director and staff for coordinating and directing the service; obtaining legal documents, and other paperwork necessary to complete the arrangements; removal of the deceased from the place of death to the mortuary within San Joaquin County, embalming or refrigeration, sanitary care of the remains; other preparation of the remains, dressing, casketing, cosmetizing; use of the facilities for viewing/visitation (3hours primarily from 9am – 12pm); Use of our facilities for the funeral service; automotive equipment (hearse, flower van and utility vehicle).

*This service **does not include**: casket or other merchandise selected, cash advances, tax or Coroner's Fee, if applicable.*

**IMMEDIATE BURIAL** ----- \$ 2,536.60  
 Our charges for immediate burial (**without any rites or ceremonies at the funeral home, Graveside or elsewhere**) include Professional Services of funeral director and staff, removal of remains, transportation to cemetery, oval top casket, and tax on casket. *This service **does not include** cash advances.*

**FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME (Out of State)** \$ 2,280.00  
 This charge includes Professional Services of funeral director and staff , removal of remains, embalming or refrigeration, dressing, casketing & cosmetizing, sanitary care of remains, and transportation to airport. **Does not** include **airline fare, airtray or casket, nor use of facilities and staff** for visitation or ceremonies, or cash advances.

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME** \$ 1,370.00

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of material like fiberboard or composition materials (**with or without an outside coving**). The containers we provide are:

**Rigid Cardboard Containers.** Our charges for direct cremation (**without ceremony**) include Professional Services of funeral director and staff, removal of remains, refrigeration (**3 days**), transportation to crematory, cremation fee (Ceres Memorial Park Crematory). **Direct Cremations includes cash advances, or tax if needed in the package.**

1. Direct Cremation with container provided by purchaser (**all such Containers must meet any applicable or crematory requirements**). \$ 900.00
