The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic service and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

PROFESSIONAL SERVICES

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This includes: 24hours a day, 365 days a year availability to respond to initial call; arrangements, coordinating service plans with parties involved in final disposition of the deceased; clerical assistance, recording vital statistics, securing permits, filing, and obtaining death certificates, and other forms of claims. The overhead includes, such as facility maintenance, equipment and inventory cost, insurance and administration expenses, and governmental compliance. ----- **\$1,095.00**

CARE OF REMAINS

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

FUNERAL SERVICE PACKAGES

While you are free to arrange services on an itemized basis, the service packages below are designed to simplify the funeral arrangements process and are offered at a reduced cost. Since these options include various types of services, no credit for deletions is possible. Additional items or services are available at additional charges.

A. TRADITIONAL SERVICE ----- \$3,185.00

**(if purchased separately \$3485 / Packages saving \$275)*

This package includes the Professional Service of the funeral director and staff for coordinating / directing the service; obtaining legal documents, and other paperwork necessary to complete the arrangements; removal of the deceased from the place of the death within San Joaquin County, embalming, refrigeration, sanitary care of the remains; other preparation of the remains, dressing, casketing, cosmetizing; use of our facility for viewing/visitation; use of our facility for the funeral service/ceremony or set up at a church or other facility; automotive equipment (hearse, flower van, family limousine) *This service **does not** include: casket, other merchandise selected, cash advances, or tax.*

B. SAME PACKAGE, except NO LIUMOUSINE ----- \$2,910.00

C. ONE DAY SERVICE ----- \$2,505.00

This includes the professional services of the funeral director and staff for coordinating and directing the service; obtaining legal documents, and other paperwork necessary to complete the arrangements; removal of the deceased from place of death within San Joaquin County, embalming, refrigeration, sanitary care of the remains; other preparations of the remains, dressing, casketing, cosmetizing; use of the facility for viewing/visitation/ or funeral service, set up at a church or other facility; automotive equipment (hearse, flower van). *This service **does not** include: casket or other merchandise selected, cash advances, tax or Coroners Fee if applicable*

D. GRAVESIDE SERVICE W/ VISITATION ----- \$2,830.00

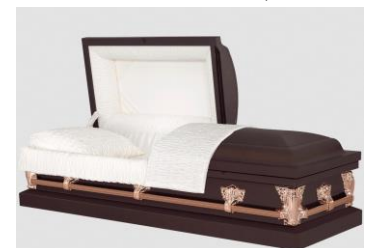
**(if purchased separately \$3,030 / Package saving \$175)*

This package includes the Professional Services of the funeral director and staff coordinating / directing the graveside service; obtaining legal documents, and other paperwork necessary to complete the arrangement; removal of the deceased from the place of death within San Joaquin County, embalming, refrigeration, sanitary care of the remains; other preparation of the remains, dressing, casketing, cosmetizing; use of the facility for viewing/visitation; automotive equipment (hearse, flower van) *This service **does not** include: casket, other merchandise selected, cash advances, or tax.*

E. SHIPOUT TO MEXICO W/ SERVICE IN OUR CHAPEL (only) ----- \$4,616.00

**(if purchased separately \$3,099 / Package saving \$175)*

This package includes the Professional Service of the funeral director and staff for coordinating / directing the service; obtaining legal documents, and other paperwork necessary to complete the arrangements; removal of the deceased from the place of the death, within San Joaquin County, embalming, refrigeration, sanitary care of the remains; other preparation of the remains, dressing, casketing, cosmetizing; use of our facility for viewing/visitation; use of our facility for the funeral service/ceremony, casket and air tray, fees for staff & time to drive to Sacramento to Consulate for processing ship out documents, California Secretary of State, San Joaquin County Recorders, Notarize documents, and three Death Certificates. *This **does not** include: set up at a church or other facility; automotive equipment (hearse, flower van, limousine) any merchandise selected, cash advances, or tax. **F. SAME PACKAGE, excepts NO VISITATION / NO SERVICE ----- \$4,085.00
(DIRECT SHIPOUT TO MEXICO)**

MINIMUM SERVICES

DIRECT CREMATION -----\$1,295.00

A direct cremation includes Professional Services of funeral director and staff, removal of remains from place of death, refrigeration, transportation to the crematory, an alternative container, the cremation itself, a plastic durable urn container, 1 Death Certificate, and 1 Burial Permit. **Cremated remains must be picked up within 3 days after cremated remains are back in our office.*

IMMEDIATE BURIAL -----\$2,536.60

Our charges for immediate burial (without any rites or ceremonies at the funeral home, Graveside or elsewhere) includes Professional service of funeral director and staff, obtaining legal documents, removal of remains from place of death, transportation to cemetery, an oval top casket, and tax on casket. *This service does not include cash advances.*

FORWARDING REMAINS TO ANOTHER FUNERAL HOME (OUT OF STATE) -----\$2,280.00

This charge includes Professional Services of funeral director and staff, removal of remains from place of death, embalming, refrigeration, dressing, casketing & cosmetizing, sanitary care of remains, and transportation to the airport. *This does not include airline fare, air tray or casket, nor the use of facilities and staff for visitation or ceremonies, or cash advances.*

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME (OUT OF STATE) -----\$1,370.00

This charge includes Professional Service of funeral director and staff, and transportation from another funeral home/airport. *This charge does not include visitation or ceremonies or place of final disposition, cash advances.*
